**BACKGROUND:** The project is located on the Grand (Neosho) River at river mile 77.0 in Mayes and Delaware Counties near Disney, Oklahoma. The project was constructed by the Grand River Dam Authority, an Oklahoma State agency. It was completed in 1940 and became operational in 1941. The structure is a concrete, multiple-arch dam with gated spillways. Total length of the dam and spillways is 6565 feet. The main spillway is equipped with twenty-one 36x25 foot tainter gates. Operation of the flood control storage in the reservoir is the responsibility of the US Army Corps of Engineers in accordance with the provisions of Section 7 of the Flood Control Act of 1944. The Corps of Engineers also has maintenance responsibilities on the Wyandotte Levee on the upstream portion of the lake. Wyandotte levee is a flood control structure that prevents flooding from Grand Lake. Areas protected include the Wyandotte school and surrounding area. Regular O&M maintenance work includes the upgrade of the electrical panel box inside the pump house station and routine maintenance to maintain the integrity of the levee.
