

## Red River Basin Above Denison Dam, Oklahoma and Texas



<u>AUTHORIZATION:</u> Public Law 98-63, the 1983 Supplemental Appropriations Act, authorized the Red River Basin, AR, TX, LA, & OK. (The study would focus on the problem area in Oklahoma and Texas.)

**TYPE OF PROJECT:** Ecosystem Restoration.

**PROJECT PHASE:** Reconnaissance.



<u>CONGRESSIONAL INTEREST:</u> Senator Inhofe, OK; Senators Hutchison and Cornyn, TX; Representatives Hall TX-4, Thornberry, TX-13, Boren OK-2, Lucas OK-3, and Cole OK-4.

NON-FEDERAL SPONSOR: Potential non-Federal sponsors in Oklahoma and Texas.

BACKGROUND: The study area consists of the upper Red River and its tributaries in Oklahoma and Texas, including the entire Red River watershed above Denison Dam (Lake Texoma), a drainage area of 39,700 square miles. State and regional water planning initiatives in Texas and Oklahoma have identified the Red River, its tributaries, and Lake Texoma as critical water resources for the region. Opportunities exist for ecosystem restoration, flood damage reduction, and related water resource development measures and development of a watershed management plan. Lake Texoma is threatened by excessive sediment and nutrient loading and toxic algae blooms. The entire Red River basin is threatened by invasive species; mesquite shrubs, native to Texas and Oklahoma, originally grew only along streams and rivers and in open groves, but now dominate millions of acres of rangelands.

**STATUS:** This project is currently awaiting funds to initiate study efforts.

**ISSUES:** Project requires appropriation.
