BACKGROUND: The Little River Watershed in and around Millwood, Dierks, DeQueen and Gillham Reservoirs provides a wide variety of water resources to the communities of southwest Arkansas. Millwood Lake, the largest lake in the system, is shallow which provides optimal conditions for the growth of exotic vegetation and increased rate of siltation. The accelerated siltation at Millwood Lake is adversely affecting the quantity and quality of water for recreation, water supply, fish and wildlife habitat and has reduced flood storage capacity. A continued proactive management of these resources is necessary to ensure a sustainable future for the region.

STATUS: Current work includes scheduled routine operation and maintenance activities.

ISSUES: Sediment surveys and mapping should occur every 15 years on Corps lakes, but no sediment survey has been completed for Millwood. If funding is not received to perform sediment surveys and mapping, accelerated siltation at Millwood Lake will continue to adversely impact the quantity and quality of water for recreation, water supply, fish and wildlife habitat and is reducing flood storage capacity.

SCHEDULE:

<u>FY 2012 Scheduled Work</u>: Funds in the amount of \$2,507,000 are being used for scheduled operations and maintenance activities.

<u>FY 2013 Budget</u>: Funds included in the President's FY 2013 budget in the amount of \$2,680,000 will be used for scheduled operation (\$1,956,000) and maintenance (\$724,000) activities. Additional funds could be used to perform sediment survey (\$100,000), continue the abandon/breach of Okay Levee (\$1,200,000), initiate master plan update (\$175,000), rehabilitate/paint upstream bottom 5 feet of 13 tainter gates (\$3,750,000), rehabilitate 6 campsites at Beard's Bluff park (\$200,000), and perform sedimentation resurvey/study (\$75,000), for a total capability of \$8,180,000.
