BACKGROUND: Council Grove Lake is located on the Grand (Neosho) River at river mile 449.9, 1.5 miles northwest of Council Grove, KS. Council Grove dam is a rolled earth-filled embankment having a total length of 6,500 feet. The outlet works consists of a gate tower, service bridge and stilling basin, with two 17-foot service gates and one 24 inch low flow pipe. Council Grove has one 24 inch domestic water supply pipe. There is a 500 foot uncontrolled spillway located 1000 feet to the west of the embankment. More than 334,700 annual recreation visits at the project in FY 2010. At conservation pool the lake covers 3259 acres.

STATUS: FY 2011 activities included routine scheduled operations and maintenance activities at the project. There were no major maintenance contracts awarded in FY 2011 at the project.

<u>ISSUES:</u> Council Grove Dam was changed to a DSAC III classification. As part of the Interim Risk Reduction Measures Plan required for a DSAC III classification, the project needs to replace aged heavy equipment.


