

**BACKGROUND:** Lake Kemp is located on the Wichita River at river mile 126.7, about 40 miles southwest of Wichita Falls in Wichita County, TX. Lake Kemp is an active flood risk management project that provides flood protection for down stream interests from the Wichita River. Lake Kemp is utilized for municipal water supply for the City of Wichita Falls, TX and Shepherd Air Force Base. It also provides water for irrigation to many downstream farmers and ranchers and also serves as a source of water to the American Electric Power (AEP) plant at Oklaunion, TX. The project plays a vital role in maintaining a base for water supply and water quality in a very arid region. Wichita County Water Improvement District No. 2 manages the lake conservation pool storage, and the US Army Corps of Engineers manages the flood control storage.

**STATUS:** FY 2011 activities included routine scheduled operations and maintenance activities at the project. There were no major maintenance contracts awarded at Lake Kemp during FY 2011.


