**BACKGROUND:** Toronto Lake is located on the Verdigris River at river mile 271 about 4 miles southeast of Toronto in Woodson County, Kansas. The project consist of a 4,712 foot rolled earth embankment with a gate-controlled ogee weir spillway with eight 40' x 25' tainter gates, seven 5' x 6' sluice gates, and one 24" diameter low-flow pipe. The project is a popular water based recreation destination with camping, picnicking, fishing, boating, hunting and other recreation opportunities. The project receives over 2,975,000 annual recreation visits. At conservation pool the lake covers 2660 acres.

**STATUS:** FY 2011 activities included routine scheduled operations and maintenance activities at the project. The one major maintenance contract awarded at Toronto Lake during FY 2011 was to repair the bridge pier caps.

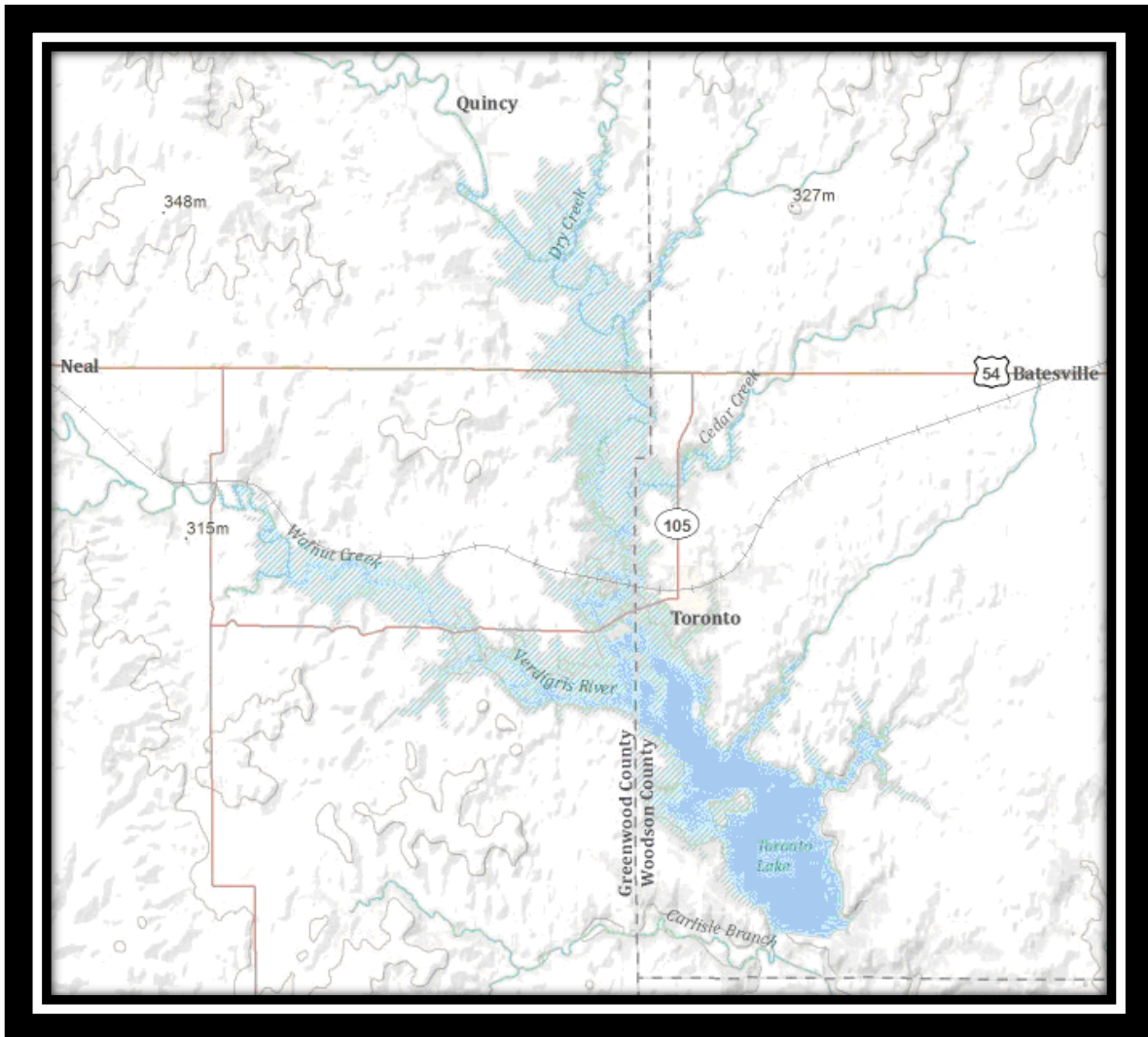
